Main Agreement:

1. The **Client** hereby engages **the Company** to provide a professional DJ Service to be performed at the date, time, & location listed below as per the terms contained herein.
2. **The Company** hereby agrees to provide said DJ Service for the **Client** at the date, time & location mentioned above.
3. **The Company** hereby agrees to skillfully & faithfully render said DJ Service in a professional manner and maintain complete control of his/her/their program.
4. The **Client** agrees to pay **the Company** the amount agreed upon below for aforementioned services.
5. Both parties hereby acknowledge that the agreements made herein are binding and no changes shall be made by either party.

Event Agreement:

Payment Agreement:

The **Client** hereby agrees to pay the sum stated herein to **the Company** for services rendered no later than the start of the event in cash only or Business Check only if agreed upon in advance. If full balance is not received by **the Company** by this time, **the Company** has the right to cancel said services.
2. The **Client** hereby agrees to pay a non-refundable deposit or reservation fee of \$100.00 minimum at the time of this contract signing if not wishing to pay the total at this time. The **Client** is aware that any additional monies paid to **the Company** is non-refundable after _____ days from the date below for any reason involving the **Client** including event cancellation..
